Re: Confirmation of BBBEE Status of Non-Profit Organisation as an Exempted Micro Enterprise

I, Rachel Boikhutso Legasa (ID number 5708030870086), in my capacity as Director and duly authorised by the Executive Board of the organisation to do so, solemnly declare that the Association for the Physically Disabled – Greater Johannesburg (NPO number 000-865, PBO number 930006515) qualifies as an Exempted Micro Enterprise (EME) in terms of the Amended BBBEE Codes which came into effect on 1 May 2015.

I further declare that:

1. the organisation (established in 1934) is a Non-Profit as well as Public Benefit Organisation and does not have any beneficial ownership and therefore is incapable of evaluation of black ownership under Code series 100
2. the Annual Budget of the organisation is less than R10 million
3. more than 75% of the organisation's beneficiaries are Black (as per the definition supplied in the Broad-Based Black Economic Empowerment Act)
